→All vendors are required by the California State Board of Equalization to have a State of California Resale Permit. For further information call (916) 227-6700. Please provide a copy of your resale permit with your application and display a copy of your permit at your booth during the event.  
 →All vendors must provide proof of vendors insurance. A certificate of insurance naming the Old Town Foundation and the City of Elk Grove as additional insured must be provided. No exceptions. A policy for this event is available for purchase through the Old Town Elk Grove Foundation for an additional \$40.  
 →All food vendors must complete and submit pages 2 and 3 from the Temporary Food Facility Operators Packet along with this application. Food vendors must read and comply with the Fire Department conditions of approval. All food vendors are responsible for additional Health Department inspection fees which are NOT included in the booth fee. Food vendors are classified as low risk or high risk by the County Health Dept. Low risk includes pre-packaged foods, hotdogs, corndogs, nachos, popcorn, cotton candy, non-dairy coffee. High risk includes any food that is cooked, barbequed or deep fried, meat or seafood, rice, pizza, sushi, tacos and all dairy drinks. For more info www.emd.saccountry.net
